Rules And Regulations :

1.ACCESS CARD

- a) Up to 6 cards per unit.
- b) \$50/- deposit per card if any card is required to be given to any service provider of the estate.

2. PARKING IN HOMEY GARDENS

(Extract from Do & Don'ts)

- A. Residents are entitled to one car park lot.
- B. Policy for residents having more than one vehicle :-
 - 1) Second vehicles will only be allowed to park in Lots No. 10, 11, 12, 13 on a first come, first serve basis, and should these lots be taken up, resident may park his/her second vehicle on the gentler portion of the slope (left side, facing into the carpark), taking measures to ensure that there is no obstruction to vehicles going up or down the slope. For safety considerations, no more than two vehicles may be parked along the slope at any time.
 - 2) The third and final option for a resident would be to park his/her vehicle outside the estate.
 - 3) Visitors's vehicle are to park at Lots No. 10, 11, 12, 13 **STRICTLY** between 9AM to 9PM daily.
 - 4) All vehicles parked at Homey Gardens are at the subsidiary proprietors / vehicle owners' risk. The Management shall not be responsible / liable for any theft, loss, damage, and action proceeding claims, suits or other misdemeanor caused to vehicles and/or their contents herein.
 - 5) Wheel-clamp policy apply in this estate.
